Ghotja fuq Xiri ta' Apparat ghal Užu Domestiku li jkun Ċertifikat li huwa Effiċċjenti fl-Užu u fil-Konsum ta' l-Enerġija

BIEX il-gvern ikompli jinċentiva l-užu aħjar ta' l-enerġija li jiproduċi l-pajjiż, il-Prim Ministro u l-Ministru tal-Finanzi qed iniedi l-iskema li ġejja immirata biex tinkoraggixxi l-užu ta' apparat għal užu domestiku li jkun ċċertifikat li huwa effiċċjenti fl-užu u fil-konsum ta' l-enerġija.

1. Tifsir

Rigward il-klassi ta' livell ta' effiċċjenza dan għandu jkun konformi ma' l-Avviż Legali 99 ta' l-2002, kif sussegwentament emendat, u ntitolat - 'Regolamenti Dwar Indikazzjoni Permezz Ta' Tikkettjar U Informazzjoni Standard Tal-Prodott Dwar Il-Konsum Ta' L-Enerġija U Riżorsi Ohra Minn Apparat Domestiku':-

Grant on the Purchase of Household Appliances for Domestic Use Certified as Being Efficient in the Use and Consumption of Energy

IN order to further encourage the better use of the energy being generated by the country, the Prime Minister and Minister of Finance has made the following scheme that aims to encourage the use of household appliances for domestic use that are certified as being efficient in the use and consumption of energy.

SCHEME

1. Interpretation

In this Scheme, unless the context otherwise requires:

'household appliance for domestic use' means any electric mains-operated household appliance intended for domestic use mentioned in the list further hereunder (schedule I), which household appliance is purchased from Malta from a registered seller on or after the effective date, and which appliance is certified as having a minimum energy efficiency class as stipulated in the column on the right hand side of the list. With regards to the energy efficiency class, this must be in conformity with Legal Notice 99 of 2002 as subsequently amended and entitled - 'Indication By Labelling And Standard Product Information Of The Consumption Of Energy And Other Resources By Household Appliances Regulations':-

'fiche' tfisser id-dokument identifikat bhala 'product fiche' fl-Avviz Legali 99 ta' l-2002 kif sussegwentament emendat;

'Malta' tfisser il-gżejjer Maltin;

'riċevuta fiskali' tfisser riċevuta kif imfissra fit-Tlettax-il Skeda ta' l-Att dwar it-Taxxa fuq il-Valur Mizjud (Kap. 406), kif sussegwentament emendat, u tinkludi kull regolament magħmul taħt l-istess Att;

'valur tax-xiri ta' apparat għal użu domestiku' tfisser il-valur finali tax-xiri ta' l-apparat għal użu domestiku kif muri fl-irċevuta fiskali.

2. Min jista' jaapplika għall-ghotja taħt din l-iskema

Din l-iskema tapplika għall-infıq li jsir fuq il-valur tax-xiri ta' apparat għal użu domestiku li jsir mill-applikant fid-data effettiva jew wara matul it-terminu ta' l-iskema.

3. Infiq li għandu jiġi rapportat

L-infiq li għandu jiġi rapportat huwa dwar il-valur tax-xiri ta' l-apparat għal użu domestiku u kif muri fl-irċevuta fiskali.

4. Kif wieħed jaapplika u dokumenti li għandhom jiġu provduti

(i) Applikazzjoniet taħt din l-iskema għandhom isiru mill-bejjiegħ registrat f'isem l-applikant wara l-ħlas komplut,

'applicant' means any person who is a resident of Malta and is 18 years of age or over on the day of application and has made a purchase in terms of this scheme;

'registered seller' means a seller who is registered with the Malta Resources Authority (MRA) to sell in Malta the household appliances for domestic use which are certified as being energy efficient in terms of schedule I above for the purpose of this scheme;

Applications for registration of sellers under this scheme shall be made in the form set out in schedule (IV) of this scheme and shall contain all the information, details and documents as required in the said form and in terms of this scheme;

'effective date' means the 1st November, 2006;

'fiche' means the document identified as 'product fiche' in the Legal Notice 99 of 2002 as subsequently amended;

'Malta' means the islands of Malta;

'fiscal receipt' means a receipt as defined in the Thirteenth Schedule of the Value Added Tax Act (Cap. 406), as subsequently amended, and also includes any regulation made by the same Act;

'purchase price of the household appliance for domestic use' means the final purchase price of the household appliance for domestic use as shown in the fiscal receipt.

2. Area of applicability

This scheme applies to the expenditure that is incurred on the purchase of a household appliance for domestic use made by the applicant on or after the effective date during the duration of the scheme.

3. Expenditure to be reported

The expenditure to be reported is in respect of the purchase price of the household appliance for domestic use as shown on the fiscal receipt.

4. Manner of application and supporting documents

(i) Applications under this scheme shall be made by the registered seller on behalf of the applicant following full

(ii) Applications shall be accompanied by the documents shown hereunder;

(a) the original fiscal receipt and the original invoice relating to the purchase of the household appliance for domestic use;

(b) a copy of the ‘fiche’ authenticated by the seller;

(c) the delivery note or its equivalent, with the delivery address clearly identified;

(d) any other document which the Minister responsible for Finance may, from time to time, require.

(iii) Only those applications that are found to conform with all the provisions of this scheme shall be eligible for payment of the grant referred to in paragraph 5 of the scheme.

(iv) Applications under this scheme, including the documents that are to be submitted with the application, shall be submitted/sent by the registered seller on behalf of the applicant to the Malta Resources Authority, Millennia, Second Floor Aldo Moro Street, Marsa, by not later than *three months* from the date of purchase of the household appliance for domestic use

5. Grant payable under this scheme

Eligible applicants may apply for a grant of 20% on the purchase of the household appliance for domestic use, subject to a maximum grant as indicated in the following schedule II:

8. Tul ta' din l-iskema

Din l-iskema tibqa' fis-seħħ għal żmien ta' sena mil-1 ta' Novembru 2006, sakemm din l-iskema ma tiġix modifikata/mitmuma permezz ta' Notifikazzjoni fil-Gazzetta, u tigġedded skond kif jahseb li hemm il-ħtiega il-Ministru responsabbi għall-Finanzi u kif tiġi hekk ppublikata permezz ta' Notifikazzjoni ohra fil-Gazzetta.

9. Emendi ghall-iskema

Il-Ministru responsabbi għall-Finanzi jżomm id-dritt li jagħmel kull tibdil f'din l-iskema bil-pubblikazzjoni ta' dak it-tibdil fil-Gazzetta.

10. Dispożizzjonijiet transitorji

Applikazzjonijiet taħt din l-iskema għal apparati għal użu domestiku li nxtraw bejn 1-1 ta' Novembru 2006 u d-data tal-pubblikazzjoni ta' dan l-avviż, għandhom jitqiesu bħala applikazzjonijiet validi taħt din l-iskema. F'dawn il-kazijiet l-applikazzjonijiet għandhom jintbagħtu *fī żmien tliet xhur* mid-data tal-pubblikazzjoni ta' dan l-avviż.

6. Payment of Grant

The grant will be paid to the applicant by cheque posted to the address shown on the application.

7. Validity of application

An application shall not be deemed to have been submitted unless it is full and complete in all material respects and unless it contains all the information and is accompanied by all the documentation requested therein.

8. Duration of the scheme

This scheme shall remain in force for a period of one year as from the 1 November 2006 unless modified/terminated beforehand by a Notice in the Gazette, and shall be renewed as deemed necessary by the Minister responsible for Finance and as shall be thus published in another Notice in the Gazette.

9. Amendments to the scheme

The Minister responsible for Finance shall have the right to make any amendments to this scheme by the publication of the said amendments in the Gazette.

10. Transitory provisions

Applications made under this scheme for household appliances for domestic use purchased between the 1 November 2006 and the date of publication of this notice shall be deemed to be valid applications under this scheme. In such cases applications shall be submitted within *three months* from the date of publication of this notice.

1. Personal information provided by the retailer will be protected and used in accordance with the Data Protection Act. Without prejudice to any Act, [the retail price and] the volume of sales shall be considered to be commercially sensitive data and will only be published in such a manner that individual retailers cannot be identified, but may be shared by/with the Malta Resources Authority, the Ministry for Finance and the VAT department. All information other than personal or commercially sensitive information may be published.
2. Retailers may be suspended or withdrawn from the scheme after notification in writing from the Malta Resources Authority.
3. Random audits may be carried out by the Malta Resources Authority or its agents. Participation in the scheme implies that the retailer is agreeing to such auditing. Original literature, in the English or Maltese language, must be available to support any claim in this return and provided upon request to the MRA.

Documentation required with application form

For the first registration or listing of any appliance:

Certified copy of technical documentation - energy efficiency test reports for each appliance qualified for a rebate. This documentation will not be required where the retailer did not import the appliances directly, provided that the wholesaler supplied the relevant documentation to the MRA. Copies of fiche or label for all other appliances listed in the document. Catalogues will be accepted in lieu of labels/fiches provided that all the information that is required on the label is included in the catalogue.

Definitions

“technical documentation” means the document identified as such in regulation 5 of the “Indication by labelling and standard product information of the consumption of energy and other resources by household appliances regulations, 2002” as amended.
 “Certified” means a statement by any authorised person of the manufacturer on the document stating “Corresponding to the original” and having this statement signed, stamped and dated. The position within the company of the signatory is also required.

Instructions for completing the application

Appliance type -

All refrigerator, freezer or refrigerator/freezer combination; air conditioner; washing machine, dryer or washer/dryer combination; dishwasher types in stock (even if they do not qualify for the rebate) sold by the retailer are to be listed.
 kWh/year for refrigerators and freezers and combinations; kWh/complete cycle for washing machines, dryers and their combination; kWh/ cycle for dishwashers; Annual energy consumption, kWh in cooling mode for air conditioners.

Climate class (cooling appliances only) – SN, N, ST, T or ranges.

Cost to customer (Lm) – Showroom price not including discounts.

Quantity sold – For 2005 for the first return, 2006 for the second return (due by the end of January 2007) and six monthly for subsequent returns (due end July and January annually, for the duration of the scheme).
